## **Hammersmith & Fulham launch pilot campaign to change smokers' behaviour and bring cleaner streets to the Borough**

One of Hammersmith & Fulham's biggest headaches is the Council's enormous annual clean-up bill to rid the streets of litter. And cigarette litter is the biggest problem, accounting for more than two thirds of all the rubbish dropped on the streets of the Borough. What's more, it has become worse since the 2007 public smoking ban was instituted, as people have taken to the streets to smoke.

But now, the Council is launching a month-long pilot campaign – commencing on **Monday 25 January** – to draw attention to this problem and kick-start a reduction in the amount of cigarette butts found on our streets.

From 25 January, Hammersmith & Fulham Council will be working with local retailers and businesses to ensure widespread availability of personal ashtrays from stores throughout the Borough, so that smokers can take responsibility for their own cigarette litter and make the streets cleaner for everyone. Entitled **ButtsOut**, these personal ashtrays are small enough to fit in a pocket, for use outside when a normal ashtray is not to hand; and they are affordable, with a suggested retail price of just 99p.

**Hammersmith & Fulham Council** are working on the pilot in partnership with corporate and social responsibility consultants **CSR Solutions** and **Keep Britain Tidy** to ensure the campaign is a success.

Activities scheduled to take place over the month of the pilot include:

- H&F Council are working with local retailers and businesses to ensure widespread availability of personal ashtrays;
- campaign posters and phone-kiosk wrappings are being set up in high footfall areas, such as transport hubs, parks, busy streets, Council offices;
- pubs and clubs are being issued with campaign beer mats; and
- street cleaners' barrows are being specially laminated with campaign branding.

Additionally, Hammersmith & Fulham Council will:

- place articles giving information about the campaign in the Council's 'H&F News' – distributed to all 85,000 households in the Borough;
- send its 'e-H&F' email direct to individuals and businesses;
- update the Council website to include campaign details on the front page; and
- dedicate Council public area plasma screens to showing Keep Britain Tidy's recent cigarette litter advert – see [www.keepbritaintidy.org/News/bigcig.aspx](http://www.keepbritaintidy.org/News/bigcig.aspx).



H&F Council really is leading the way in London with this pilot, and it is envisaged that other London Boroughs will follow this initiative subsequently. This is especially timely, as the capital seeks cleaner streets in preparation for the 2012 Olympic Games, when the world comes to London.

## **Notes to editors**

1. There will be a **photocall on Thursday 28 January, 12.30pm**, to launch the campaign, where key Council personnel and politicians will be present and available for comment – please contact the team for more information on this (contact details below).

Officers from the council, in partnership with the Police's Safer Neighbourhood Teams regularly challenge persistent litter-dropping offenders, and have the power issuing Fixed Penalty Notices of £75 for the misdemeanour under the Environmental Protection Act 1990. If litterbugs refuse to pay the fine they can even end up with a criminal record.
5. While the council urges smokers to buy a ButtsOut personal ashtray, it is continuing to proactively seek out persistent butt droppers and litter louts. Highly visible proactive 'beats' are inspecting every street in the Borough – at least once every ten working days – and key routes are checked daily, meaning there is an increased chance that litter bugs who do not get the message will be penalised.
6. Cigarette litter in the UK
  - approximately 21.5 billion butts are littered every year in the UK – if placed end to end these would cover 430,000 kilometres and circle the earth 10.75 times
  - over 122 tonnes are dropped daily
  - levels have doubled in England since the smoking ban introduced in July 2007
  - 98 per cent of town centres cite cigarette litter as a major issue
  - 42 per cent of smokers think it's acceptable to drop butts as litter
6. Cigarette butts harm the environment
  - it can take between 18 months and 500 years for a stub to decompose
  - cigarette filters are made of cellulose acetate, a form of plastic which does not quickly degrade and persists in the environment
  - cigarette butts are carried by storm water and dumped into our waterways, where chemicals such as cadmium and lead leach out, impacting water quality
  - cigarette butts have been found in the stomachs of birds, fish and other marine animals and wildlife
